# During October, ERE Board held 6 meetings which resulted in 25 decision makings, among which:

 Licensing "PARISOL" company and Albanian Power Core company in electricity production activity in Fier Region, for a 25-year term, from the photovoltaic plant with an installed capacity of 2 MW for "PARISOL" company, the exercise of whose activity must begin no later than 28.09.2025 and from the photovoltaic plant with a production capacity of 40.56 MW for Albanian Power Core company, the exercise of whose activity must begin no later than 27.03.2027; as well as of "Erseka Solar Park 1" company in electricity trading activity, for a 5-year term.

• On opening the procedure to license the companies:

a. "SLR ALBANIA" company in electricity production activity from the photovoltaic power plant with an installed capacity of 2MW, located in Fier district, for a period of 25 years.

b. "SPV BLUE 2" company in electricity production activity from "Blue 2" photovoltaic park, with an installed capacity of 50MW, located in Fier district, for a period of 25 years.


c. "AXPO ALBANIA" company in electricity trading activity.

# Extending the term of ERE Board decision for reviewing the requests of the following companies:

- For licensing in electricity production activity of the companies:
  - i."Samasol" company;
  - ii."Rebesol" company;

## **Authorizations:**

- Obtaining authorization from ERE for the change of the partner who controls the interests of "AlbEsp Trading & Consulting" company.
- Opening the procedure to review the request of "HYDROPOWERPLANT CONSTRUCTION" company for obtaining authorization from ERE for the transfer (through mortgage) of its immovable assets to guarantee the repayment of obligations to the lending party "AMERICAN INVESTMENT BANK" company

## Other decisions such as:

- Approval of the joint document of the three energy regulators, ERE, ARERA and RAAEY: "Approval of an amendment in TAP Network Code and the TAP Tariff Code, proposed by TAP AG on October 29, 2024.
- Opening the procedure for reviewing some amendments to the Electricity Market Rules, approved with ERE Board Decision No. 347, dated 27.12.2022, as amended.

#### Other decisions on licensees or subjects that have initiated an application for licensing:

- Suspension for 90 days of ERE Board decision on the review of the request of "KOKA & ERGI ENERGY STAVEC" company for license modification in electricity production activity.
- Some amendments in ERE Board decision no. 132, dated 02.07.2024, "On licensing "GreeNNat Solar Park Ballsh" company in electricity production activity", according to the provisions of which the company must begin the exercise of electricity production activity for the installed capacity of 25 MW upon the entry into force of these amendments, as well as the exercise of the licensed activity for the full capacity of 100 MW no later than 11.01.2028.
- License renewal of "DEVOLL HYDROPOWER" company in electricity trading activity, for a period of 5 years, starting from 06.03.2025.
- Some amendments in ERE Board decision no. 9, dated 21.01.2022, "On licensing "BREÇANI R.O.S.P" company in electricity production activity from "Drita" hydroelectric power plant, with an installed capacity of 1980 kW, as amended, imposing new binding conditions for the company.

ERE is responsible for drafting tariff and prices methodologies for regulated activities in accordance with the legislation in force and based on its analysis, proposes improvements to existing methodologies.

Regarding this area of responsibility, during October decisions were made on:

a.Approval of the sale price of electricity supplied by the Supplier of Last Resort for September 2024 of about 16.86 ALL/kWh for customers connected at the 35 kV voltage level. During October, 6 hearing sessions were held, with customers and licensees, with the aim of clarifying the details necessary to resolve the respective complaints, or to continue the licensing process of the subject in question.

#### Trilateral MEDREG - ECRB - CEER Workshop

On 9 October 2024, in Lisbon and online, the annual Trilateral Workshop of MEDREG - Association of Mediterranean Energy Regulators was organized, hosted by the Portuguese Energy Regulator - ERSE. Mr. Hasan OZKOC, Secretariat Director at MEDREG, emphasized the importance of such meetings for the exchange of knowledge between neighboring regions.

In the second session, Ms. Erjola Sadushi, Member of ERE Board during her speech as part of the panel, emphasized the key role of customer empowerment in providing flexibility to the network, an important factor in advancing the energy transition.

## Signing the Memorandum of Cooperation with RAAEY
