DECISION

No. 41, of date 11.02.2026

ON
DEFINING THE ELECTRICITY SALE PRICE FROM THE SUPPLIER OF LAST
RESORT FOR JANUARY 2026 FOR THE CUSTOMERS CONNECTED IN 35 KV
VOLTAGE LEVEL

Based on Articles 16 and 87, point 4 of Law no. 43/2015 “*On Power Sector*” as amended; the *Methodology on defining the electricity sale price from the Supplier of Last Resort*, approved with ERE Board Decision no. 201, of date 04.12.2017, as amended with Decision no. 144, of date 25.06.2018 and Decision no. 233, of date 20.12.2019; and Article 15 of the *Regulation for ERE organization, operation and procedures*, approved with ERE Board Decision no. 96, of date 17.06.2016; ERE Board, on their meeting of date 11.02.2026, after reviewing the report protocol no. 540/1, of date 09.02.2026, prepared by Tariffs and Prices Directory “*On defining the electricity sale price from the supplier of last resort for January 2026 for the customers connected in 35 kV voltage level*”,

Observed that:

I -Legal and Procedural aspects

1. Submission of the request from FSHU company.

- FSHU company. With the official letter Protocol no. 584, of date 02.02.2026, ERE protocol no. 540, of date 05.02.2026, submitted the request on approving the electricity sale price for January 2026, for the customers connected in 35 kV voltage level, that are supplied from the Supplier of Last Resort.

2. Process of reviewing the documentation by ERE

The request has been reviewed in accordance with Article 15 of the “Regulation on ERE Organization, Operation and Procedures”, approved with Decision no. 96, of date 17.06.2016, as well as in support of Articles 16 and 87, point 4, of Law no. 43/2015, “On Power Sector”, as amended, as well as the “Methodology for defining electricity sale price from the Supplier of Last Resort” approved with ERE Board Decision no. 201, of date 04.12.2017, as amended.

II – Analysis for the calculation of electricity sale price from the Supplier of Last Resort for January 2026, for the customers connected in 35 kV voltage level

1. Electricity purchase on exchange

For January 2026, FSHU company has ensured the electricity quantity to cover the request for energy of this customer's category through daily/monthly purchased at the Albanian Power Exchange (ALPEX).

2. Calculation of Weighted Average Purchase Price (ÇBEt)

Referring to the submitted data, it results that the weighted average purchase price of electricity (ÇBEt), calculated from the company for January 2026 is 9.30 ALL/kWh. For checking the submitted data, it was considered reasonable their calculation, from which resulted that the weighted average purchase price of electricity is 9.30 ALL/kWh, as reflected even in the calculations submitted from the company itself.

3. Components according to the Methodology (Article 8, Decision no. 201, of date 04.12.2017, as amended) according to the respective methodology, the used components for the calculation of electricity sale price are as follows:

- **Weighted average purchase price of electricity purchase (ÇBEt) for January 2026: 9.30 ALL/kWh;**
- **Transmission service tariff** of electricity purchase for 1 January 2025 – 31 December 2027, approved with ERE Board Decision no. 279, of date 16.12.2024: **0.85 ALL/kWh;**
- **Distribution service tariff** on 35 kV voltage level, according to ERE Board Decision no. 288, of date 23.12.2024, "On letting into force ERE Board Decision no. 73, of date 13.04.2022": **1.55 ALL/kWh;**
- **Administrative cost: 1.06 ALL/kWh;**
- **Official exchange rate published by the Bank of Albania (ALL/Eur),** for each respective date of period **31.12.2025 – 30.01.2026.**
- Implementing the "Methodology for defining the electricity sale price from the Supplier of Last Resort", referring to FSHU company application and being supported on ERE calculations, the electricity sale price for the customers supplied from the Supplier of Last Resort for January 2026, is calculated as follows:

<i>The electricity price supplied by the Supplier of Last Resort for the customers connected in 35 kV voltage level for January 2026</i>

TSHt Tariff of using the distribution network	ALL/kWh	1.55
Electricity Price = CBEt + Pr * CBEt + TRr + TSHt + CA	ALL/kWh	13.04

- Based on each element of the calculated formula as well as considering the submitted data submitted on the company's application, it results that:

- The electricity sale price for the customers connected in 35 kV voltage level, supplied from the Supplier of Last Resort results *13.04 ALL / kWh for January 2026*.

For all of the above, ERE Board,

Decided:

1. Defining the electricity sale price supplied from the Supplier of Last Resort for January 2026 of about 13.04 ALL/kWh for the customer connected in 35 kV voltage level.
2. The change of each element component element in the calculation of electricity sale price supplied from the Supplier of Last Resort for the customer category that is specified on this decision, shall constitute a reason for the review of ERE Board Decision.
3. Tariffs and Prices Directory, shall inform the applicant regarding ERE Board Decision.

This decision enters immediately into force.

Each party involved in this procedure may request from ERE, within 7 calendar days from the date of receiving this decision, the review of the Board's decision if there are provided new evidences that may lead the Board to take a decision different from the previous one or for identified material errors. For this decision, may be filled an appeal on Tirana Administrative Court within 45 calendar days from the date of publication in the Official Gazette

This decision is published on the Official Gazette.
